- **Re: Euro 52,500,000 Class A Partly Paid Senior Asset-Backed Notes ISIN XS1990805399 due April 2022 (hereinafter, the “Senior Notes”) and Euro 3,158,000 Class B Partly Paid Junior Asset-Backed Notes ISIN XS1990805472 due April 2022 (hereinafter, the “Junior Notes”) and, together with the Senior Notes, the “Notes”) issued on April 30, 2019 by Sovereign Credit Opportunities SA acting in respect of its Compartment Trade Finance II**

as far as the Notes are concerned, we hereby inform you that during the Collection Period ended on August 14, 2023:

- a) As a result of the Trigger Notice served on the Issuer by the Senior Noteholders via a Written Resolution taken on April 26, 2022, all Payments under the Securitisation will be made in accordance with the Post-Enforcement Priority of Payments
- b) The paid-up amounts of the Notes as of August 14, will be as follows:
 - Euro 45,649,626.63 as regards the Senior Notes, and
 - Euro 3,158,000.00 as regards the Junior Notes
- c) No Collection were received during the Collection Period.

Since the last Payment Date, the Issuer has received invoice for Euro 26,214.58. Due to the insufficient Issuer Available Funds, all unpaid invoice will be paid under reference 3C on the next Payment Date, if the Issuer Available Funds will be sufficient.

- d) On the paid-up amount, interests accrued as follows:
 - Euro 122,841.88 as regards the Senior Notes, and
 - Euro 2,719.39 as regards the Junior Notes
