- a) As a result of the Trigger Notice served on the Issuer by the Senior Noteholders via a Written Resolution taken on April 26, 2022, all Payments under the Securitisation will be made in accordance with the Post-Enforcement Priority of Payments
- b) The paid-up amounts of the Notes as of October 14, will be as follows:
 - Euro 45,649,626.63 as regards the Senior Notes, and
 - Euro 3,158,000.00 as regards the Junior Notes
- c) No Collection were received during the Collection Period.

Since the last Payment Date, the Issuer has received invoice for Euro 33,827.38. Outstanding invoices still not settled amounts to Euro 33,827.38. Due to the insufficient Issuer Available Funds, all unpaid invoice will be paid under reference 3C on the next Payment Date, if the Issuer Available Funds will be sufficient.

- d) On the paid-up amount, interests accrued as follows:
 - Euro 118,879.24 as regards the Senior Notes, and
 - Euro 2,631.67 as regards the Junior Notes
